

Health and Safety Reps are Entitled to Attend Training

Elected Health and Safety Representatives are entitled to **two days paid leave each year** (as per Schedule 2, Section 12 of the Health and Safety at Work Act 2015).

The Health and Safety at Work (Worker Engagement, Participation and Representation) Regulations (2016) also entitles health and safety representatives to choose a training opportunity (whether initial training or additional training), in consultation with the PCBU (the School Board) regarding the time, date, location and costs relating to the training (Section 23 of the Regulations).

Once the Health and Safety Representative has made a request to use his or her annual training, the School must make a decision as soon as practicable or not later than 3 months from receiving the request.

The School must pay for the training fees and any other reasonable expense that the Health and Safety Representative may incur, such as travel and accommodation (Section 24 of the Regulations).

Initial Health and Safety Training

This is a two day course for both new and existing Health and Safety Representatives. This course will provide an introduction to the Health and Safety at Work Act 2015 and an opportunity to complete the required Unit Standard (29315); ‘Describe the role and functions of the Health and Safety Representative in a New Zealand workplace’.

Stage 2 Health and Safety Training

This two day course is for experienced Health and Safety Representatives who have already completed the Initial Training course. This course builds skills in hazard and risk management and injury and accident investigation.

Health and Safety Training for Principals

This one day course provides an introduction to the Health and Safety at Work Act 2015 and looks specifically at the role of a school Principal and the obligations as an Officer under the Act. The aim of the course is to provide Officers (as defined by the Act) with the skills, knowledge and competency to assist them to:

- Provide workplace health and safety leadership
- Comply with their duties under the Act
- Engage with Health and Safety Representatives and workers
- Develop and implement health and safety policies, procedures and systems
